

## REGIONAL DISTRICT OF CENTRAL OKANAGAN

### BYLAW NO. 1531

---

A bylaw to establish a service within a portion of the Central Okanagan East Electoral Area for the purpose of designing and constructing water infrastructure to connect to the Falcon Ridge Water System Service Area established under Bylaw 369, as amended.

---

WHEREAS a regional district may, by bylaw, establish a service under the provisions of Part 10 of the *Local Government Act*;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a service for the purpose of designing and constructing water infrastructure within a portion of the Falcon Ridge community in Central Okanagan East Electoral Area;

AND WHEREAS in accordance with Section 337 of the *Local Government Act*, the Regional District has received a valid petition for the service;

AND WHEREAS the Director of the Central Okanagan East Electoral Area has consented to the establishment of the service area;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District hereby establishes within the Central Okanagan East Electoral Area a service for the purpose of designing and constructing water infrastructure for part of the Falcon Ridge community, to be known as the "Falcon Ridge Water System East Service Area".
2. The participants in the service area, established under Section 1, are a portion of the Central Okanagan East Electoral Area.
3. The boundaries of the service area are shown outlined on Schedule "A" attached hereto and forming part of this bylaw.
4. The annual costs for the service established in Section 1 shall be recovered by:
  - a) The requisition of money under Section 387 to be collected by a parcel tax imposed in the manner provided by Section 388, and
  - b) The imposition of fees and other charges that may be set by separate bylaw for the purpose of recovering these costs.
5. The maximum amount that may be requisitioned under Section 387 for the service shall be \$20,000.00.


6. This bylaw may be cited as the "Regional District of Central Okanagan Falcon Ridge Water System East Service Area Establishment Bylaw No. 1531, 2023".

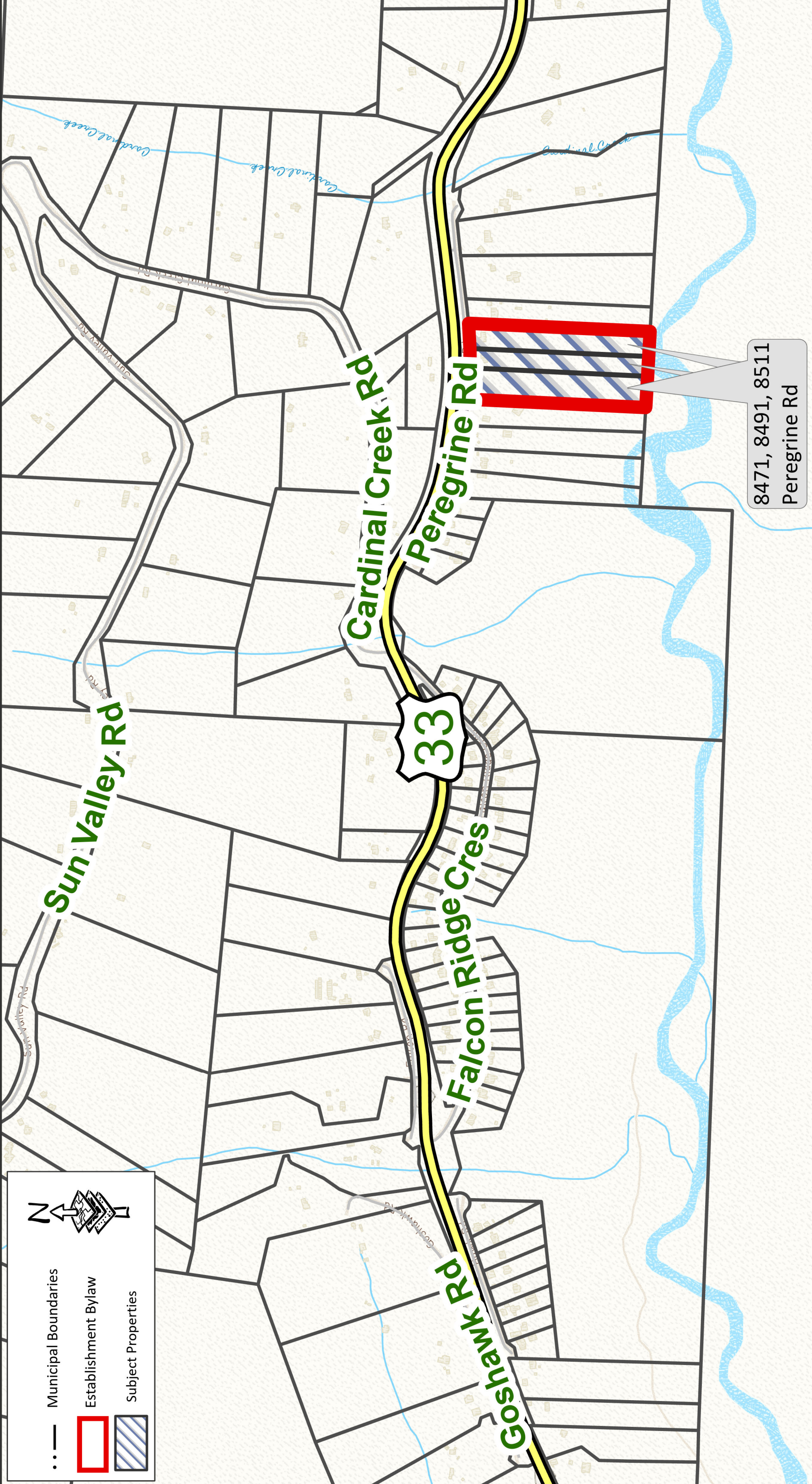
