BYLAW NO. 1428

Being a bylaw to provide for park use permit fees and charges for regional parks services and facilities within the Regional District of Central Okanagan

WHEREAS the Regional Board deems it necessary to adopt a bylaw that provides for park use fees and charges for regional parks services and facilities.

NOW THEREFORE THE REGIONAL DISTRICT OF CENTRAL OKANAGAN, IN OPEN MEETING ASSEMBLED, ENACTS AS FOLLOWS:

1. The Regional Parks Services and Facilities Fees and Charges are as set out in Schedule 'A' attached hereto and forming part of this bylaw.
2. This bylaw may be cited as "Regional District of Central Okanagan Regional Parks Services and Facilities Fees and Charges Bylaw No. 1428, 2018.





*** Fee Exemptions:**

Special Event or Activity: Fee exemption may apply when all participants are under 16 years of age, and for registered charities at the discretion of the Director of Parks Services.

Research Activity and Temporary Service Access: fee exemption may be made when the activity provides a benefit or improvement to the park system.

Recreational Activity: No fees are applied to self-guided programs.
